Method of measurement: 2019 and 2020 estimates were based on gallons per minute and the length of time the pump was operated. 2011 to 2018 estimates were based on the lack of well use.

- (3) The type of water right or rights claimed by the party for the extraction of groundwater.

  Cross-Defendants assert overlying water rights and possibly riparian rights for the extraction of groundwater from a water well located on or near their properties from the Ojai Groundwater Basin. Cross-Defendants also assert a right to use groundwater under the self-help doctrine, if prescriptive rights to extract groundwater from the basin are determined. In addition, Cross-Defendants claim riparian rights to the waters of Thacher Creek, which runs through Cross-Defendants' properties.
- (4) A general description of the purpose to which the groundwater has been put.
  Cross-Defendants extract groundwater from the Ojai Groundwater Basin for use in dust control on roads, fruit tree irrigation, protected Oak and Sycamore tree irrigation, and for emergencies.
