3 PLEASE TAKE NOTICE THAT the Order to Show Cause (“OSC”) hearing regarding
4 service by publication of the summons on 61 remaining unserved Cross-Defendants in the
5 Ventura County Star, which was originally set for June 30, 2021, was continued by the Court.
6 The OSC hearing will take place on July 19, 2021, at 3:00 p.m. in Department S10 of the Los
7 Angeles County Superior Court, which is located at 312 North Spring Street, Los Angeles, CA
8 90012. The Court Ordered the City of San Buenaventura to send Notice of the continued OSC
9 hearing along to the 61 unserved cross-defendants identified in the application for service by

16 service by publication should not be ordered by the Court.
