NOTICE OF RULING


On February 16, 2022, the parties appeared at an Informal Discovery Conference via Zoom under Code of Civil Procedure section 2016.080, the Honorable William F. Highberger, Judge presiding. The Court made the following orders and determinations:

1. The Court relieved the parties of the obligation to videotape the depositions scheduled for February 15, 2022 and February 16, 2022.
2.
