1	Casitas water (with appropriate easements), approved by Casitas. The amount of water used by
2	each parcel is not measured. Instead, an agreed-on cost-sharing formula among the parties has
3	been used, based on estimated use by each parcel. The Trust share of such use is estimated at
4	15% of total Casitas water used. The Casitas account and records are kept by the final parcel
5	owner in the line of parcels in the agreement, and to date the Bliss Trust does not have complete
6	records available. However, since 2017 the annual allocation of water from Casitas to the parties
7	in the agreement, which has not been exceeded, has been 10,954 units. The Trust share to be paid
8	is 15% of that, regardless of the actual use.
9	(9) The trust has riparian rights to the surface water, if any, in Lion Creek. See deed Ventura
