MEMORANDUM OF POINTS AND AUTHORITIES

1. <u>INTRODUCTION</u>

Respondent and Cross-Complainant, City of Buenaventura ("CITY") hereby applies for an Order directing that the Summons of the Third Amended Cross-Complaint for Violation of Reasonable JJse; Violation of Public Trust; Declaratory Relief – Pueblo and/or Treaty Water Rights; Declaratory Relieve – Prescriptive Water Rights; Declaratory Relief – Appropriative Water Rights; Comprehensive Adjudication; Declaratory Relief – Municipal Priority; Declaratory Relief – Human Right to Water and Declaratory Relief filed in this action on January 2, 2020 (hereinafter "Third Amended Cross Complaint") be served on the 51 cross-defendants named in this action which remain unserved because the service addresses are fenced and gated, by publication in a newspaper of general circulation, pursuant to Code of Civil Procedure section 415.50. Service on these remaining unserved Cross-Defendants is requested to be by publication pursuant to Code of Civil Procedure section 415.50 in the *Ventura County Star*, which is a newspaper of general circulation in the County of Ventura which is the location of the Properties. This newspaper is the one most likely to give notice to the Cross-Defendants because it is the major newspaper covering the area wherein the Properties at issue in this case lie, and therefore where these Cross-Defendants are residing. (Code Civ. Proc., § 415.50, subd. (b).)

A copy of the Summons and Third Amended Cross-Complaint could not be served on those Cross-Defendants listed in Exhibit "A" by any of the following methods:

- 1. Handing a copy to the person to be served. (Personal service Code Civ. Proc., § 415.10).
- 2. Leaving a copy, during usual office hours and in the office of the person to be served, with the person who apparently was in charge and by thereafter mailing copies (by first

class mail, postage prepaid) to the person to be served at the place where the copies were left. (Service on a corporation, partnership, association, or public entity - Code Civ. Proc., § 415.20(a)).

- 3. Leaving a copy at the dwelling house, usual place of abode, or usual place of business of the person to be served in the presence of a competent member of the household or person apparently in charge of his office or place of business, at least 18 years of age, who shall be informed of the general nature of the papers and by thereafter mailing copies (by first class mail, postage prepaid) to the person to be served at the place where the copies were left. (Service on natural person, minor, incompetent, or candidate Code Civ. Proc., § 415.20(b)).
- 4. Sending (by first class mail or airmail) a copy to the person to be served, together with two copies of required form of notice and acknowledgement and a return envelope, postage prepaid, addressed to the sender. (Service by mail Code Civ. Proc., § 415.30).
 - 5. Any other method (Code Civ. Proc., §§ 413.10, 413.30).

(See Declaration of Marnie Prock ("Prock Decl."), filed concurrently herewith.) CITY seeks an order from the Court to publish the Summons of its Third Amended Cross-Complaint for the subject properties which are surrounded by fences and gates. As discussed herein, service of the Summons by publication is proper because each Cross-Defendant has an interest in the Property, which is subject to the Court's jurisdiction. (See Code Civ. Proc. § 415.50, subds. (a)(1)-(2).) Additionally, CITY has exhausted all reasonable efforts to serve such Cross-Defendants in any other manner specified in Code of Civil Procedure sections 415.10 through 415.30. Thus, CITY seeks to serve the Cross-Defendants by publication pursuant to Code of Civil Procedure section 415.50 so that it may proceed with this Action.

I. <u>LEGAL STANDARD FOR SERVICE BY PUBLICATION</u>

A party may effectuate service by publication when it appears to the satisfaction of the Court that a party to be served cannot with reasonable diligence be served by another method specified in Code of Civil Procedure sections 415.10 through 415.30. Reasonable diligence requires a "thorough systematic investigation and inquiry conducted in good faith by that party, agent or attorney." (*Watts v. Crawford* (1995) 10 Cal.4th 743, 749, n. 5 [citations omitted].)

In addition to the reasonable diligence requirement, the Court must also find the following:

- (1) A cause of action exists against the party upon whom service is to be made or he or she is a necessary or proper party to the action.
- (2) The party to be served has or claims an interest in real or personal property in this state that is subject to the jurisdiction of the court.

(Code Civ. Proc., § 415.50, subd (a)(1)-(2).) Upon completion of service by publication, service of the summons is deemed complete as required by Government Code section 6064. (Code Civ. Proc., § 415.50, subd. (c).) All requisite facts are present to afford the Court authority to issue an order for publication of the Summons pursuant to Code of Civil Procedure section 415.50.

II. SERVICE BY PUBLICATION IS APPROPRIATE BECAUSE CITY HAS EXHAUSTED ALL REASONABLE EFFORTS TO SERVE KNOWN CROSSDEFENDANTS

Based on a thorough and systematic investigation in good faith, CITY cannot with reasonable diligence serve the Cross-Defendants listed in Exhibit "A", other than by publication. Specifically, CITY has conducted exhaustive research through the Ventura County Assessor records, real property records and TLO searches of records related to ownership of the gates properties at issue. Additionally, over the past year, CITY has twice attempted personal service, and sent three mailings with Notices of Acknowledgment of Receipt and self-addressed stamped return envelopes pursuant to Code of Civil Procedure § 415.30. For these Cross-Defendants behind fences and gates, the CITY also attempted to make appointments for personal service by

1	researching current telephone numbers and calling each property owner. (Prock Decl. ¶¶ 10-28.)	
2	These efforts all proved unsuccessful, and the CITY therefore seeks an order for publication	
3	pursuant to Code of Civil Procedure section 415.50.	
4		
5	2. <u>PUBLICATION IN VENTURA COUNTY STAR IS APPROPRIATE</u>	
6		
7	A. , The Ventura County Star is a Newspaper of General Circulation and will	
8	Satisfy the Publication Requirements in this Action	
9		
10	Pursuant to Code of Civil Procedure section 415.50, subdivision (c), the duration of the	
11	publication of the summons is determined by Government Code section 6064, which provides:	
12		
13	Publication of notice pursuant to this section shall be once a week for four successive weeks. Four publications in a newspaper	
14	regularly published once a week or oftener, with at least five days intervening between publication dates, are sufficient. The period of	
15	notice commences with the first day of publication and terminates at the end of the twenty-eighth day, including therein the first day.	
16	The Ventura County Star is a newspaper of general circulation published and distributed	
17	in Ventura County, where the Property is located, and which is most likely to give actual notice of	
18	the pendency of the proceedings herein to the unserved Cross-Defendants. (Prock Decl., ¶ 29.)	
19		
20	III. <u>CONCLUSION</u>	
21	Based on the foregoing, CITY respectfully requests that:	
22		
23	1. The Court issue an Order for Publication of the Summons as to the Cross-	
24	Defendants listed in Exhibit "A", and allow CITY to serve the Summons by publication in	
25	Ventura County Star once a week for four consecutive weeks as soon as is reasonably practicable;	
26	2. The Court Order that the published Summons shall name each Cross-Defendant as	
27	specified in Exhibit "A."
