

1 ORDER

2 IT IS ORDERED that the service of the summons in this action be made upon each of the
3 heirs and devisees of certain deceased Cross-Defendants and two unserved Cross-Defendants
4 behind gate and fence as attached in Exhibit "A", by publication thereof in the *Ventura County*
5 *Star*, a newspaper of general circulation, and serving the County of Ventura, California, and that
6 said publication be made at least once a week for four successive weeks.

7 IT IS ORDERED that Cross-Complainant CITY OF SAN BUENAVENTURA has no
8 duty to mail a copy of this Order for Service by Publication or the Summons and Third Amended
9 Cross-Complaint to each such heirs and devisees as their identities are unknown to Cross-
10 Complainant.

11 IT IS ORDERED that Cross-Complainant CITY OF SAN BUENAVENTURA will
12 overnight mail a copy of this Order for Service by Publication and Service of Summons by
13 Delivery to the Secretary of State for the California limited liability company and a copy of the
14 Summons and Third Amended Cross-Complaint to the two unserved Cross-Defendants behind
15 gate and fence.

16 Service upon Cross-Defendant Shanks Investment Group LLC shall be effective 10 days
17 from the date of service of the documents upon the California Secretary of State, pursuant to
18 California Corporations Code sections 1702(a), 15901.16(c)(1) and 17701.16(c).


