2 3 On July 6, 2021, the parties appeared at a further status conference, the Honorable 4 William F. Highberger, Judge presiding. The parties stated their appearances on the record and/or 5 they are reflected on LA Court Connect records. The Court made the following orders and 6 determinations: 7 8 1. The Court granted the City of San Buenaventura's (City) request to continue the 9 order to show cause (OSC) hearing regarding service by publication of remaining 10 unserved Cross-Defendants to the July 19, 2021 status conference. The City shall 11 provide notice of the OSC and submit the required paperwork to the Court to 12 request the approval of an order for service by publication on July 19, 2021. 13 14 2. The Court authorized the City, together with Cross-Defendants the Ventura River 15 Water District, Meiners Oaks Water District, the Wood-Claeyssens Foundation, 16 and the Rancho Matilija Mutual Water Company (Proposing Parties), to lodge the 17 public review draft of the proposed physical solution, dated May 17, 2021, on July 18 12, 2021. The Court instructed that the proposed physical solution clearly indicate 19 that it is a draft document and that the Section 8 Findings be redacted. The Court 20 further instructed that the lodged document be made available to all parties via File 21 & Serve Xpress and that a notice of lodgment be filed with the Court on July 12, 22 2021. Written objections to the proposed physical solutions may be filed and 23 served by other parties. Objections are limited to six (6) pages of the text (without 24 the caption, attachments, declarations, or exhibits) and must be served by 4:30 25 p.m. on July 15, 2021 and filed by July 16, 2021. Any reply must be served by 26 noon on July 19, 2021 and filed by the time of the hearing. The reply is limited to 27 50% of the total number of opposition pages. 28

8	appoint a scientific advisor by July 8, 2021, in light of the papers filed by Cross-
9	Defendants Rosanna Garrison and Gregg Garrison. Replies must be filed and
10	served by July 9, 2021.

12	5. The Court instructed the City to provide an update on the default process and
13	status in the report for the July 19, 2021 status conference.

15	6. The Court determined that parties who have stipulated to the proposed physical
16	solution need not serve (or work on drafting) Initial Disclosures until after March
17	1, 2022, when the Court will reconsider the issue.
